Time commitment

Advisory Board Members

- 1-2 x 1hr meetings per year online or in-person held with with the Director and/or Trustees or other MTS team members to give strategic advice and insight
- Ad-hoc advice on bespoke projects
- Opportunity to attend events and programmes and represent Make the Sunshine at key events
- This is a **voluntary**, **non-governance role**, but a vital one your advice and support will make a real difference to our organisation and communities.

Make the Sunshine Trustees

- Approx 1-2 hrs per month supporting a key area of our work
- Includes 4 board meetings per year Sept, Dec, March & June (in person or hybrid, in Somerset). Plus one ½ day away-day per year.
- Time for reading papers or contributing to strategic planning
- Being an ambassador for Make the Sunshine
- Opportunity to attend events and programmes and represent Make the Sunshine at key events

Trustee roles are voluntary but hugely rewarding. You'll be helping to shape a growing creative organisation that brings real change to people's lives.



As a trustee of Make the Sunshine CIO, you'll help guide the organisation's mission, ensure we stay true to our charitable purpose, and make thoughtful decisions that help us grow safely and sustainably.

Trustee Responsibilities Include

Working in Make the Sunshine's best interests: Acting with integrity, honesty, and independence, putting the organisation's purpose—and the communities we serve—at the heart of decisions.

Overseeing long-term strategy and planning: Helping shape and grow our direction, vision, and priorities. Offering guidance to keep us on track.

Ensuring legal and financial compliance: Making sure we meet our obligations under charity law and our governing document. Approving budgets, monitoring finances, and ensuring resources are used wisely.

Managing risks and safeguarding: Helping to identify and manage risks around safeguarding, finance, operations and reputation. Ensuring policies and processes are in place and working.

Supporting and being a critical friend: Acting as a "critical friend" to the staff team—supportive, but challenging to ensure we are the best we can be. Ensuring we have the right skills, policies and people in place.

You don't need to be an expert in charity law or governance. We'll provide:

- An induction
- Ongoing support from the Chair and Director
- Opportunities for training and learning
